## About Maydan

Maydan is the first Italian journal of studies on the Arab, Semitic and Islamic worlds run by PhD students and graduates, whose main purpose is to encourage the production of first research articles by young scholars. The journal revolves around a broad conception of the Arab, Semitic and Islamic worlds, which includes the geographical areas of the Middle East, North Africa, the Sahel region, Caucasus, and Central and South-East Asia. In addition, the journal aims to explore the presence and experiences of the Arab, Semitic and Islamic Worlds outside the regions traditionally characterised as "Arab" or "Islamic" and highlight differences within these worlds. Maydan welcomes contributions focused on the connections between these areas and the globalised world's political, economic, social, and cultural dynamics. The journal's areas of interest include anthropology, archaeology, arts, economics, geography, history, law, linguistics, literature, philosophy, political science, religion, and sociology. Moreover, the journal aims to support a critical reflection on the concept of Area Studies, problematising culturalist approaches that reproduce an essentialist and colonialist vision of the Arab, Semitic and Islamic Worlds.

*Maydan* is published annually. The articles submitted to the journal are subjected to a double peer review process. The accepted languages are Italian, English, and French. The journal accepts contributions from PhD students, graduates, and master students from foreign and Italian universities.
